The following procedure is to be followed in <u>all</u> situations of suspected child abuse.

• Suspicion of abuse of a child by a person involved in the Scouting program whether registered or unregistered.

Contact the Scout Executive or Assistant Scout Executive as soon as possible. Provide as much information as possible about the situation. The Scout Executive, or designee, will advise you of any action you should take.

Report the incident to the local Police and Human Services Departments. If the youth is a member of the Scouting program contact the Scout Executive, or designee, and advise them of the incident.

All instances of suspected child abuse are to be reported to the police in the locality where the incident occurred.
